MAXIMUM VERDICT AWARDED

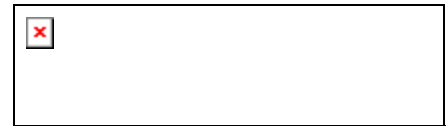
